

# *Help Northwest Kansas GROW with the Gift of Grain*

## Steps to Make a Charitable Gift of Grain

*As a donor, you should follow these steps to ensure that ownership of the gifted grain is transferred prior to sale and you receive recognition for your gift.*

1. Contact Greater Northwest Kansas Community Foundation (GNWKCF) at 785-734-2406 to acknowledge the gift of grain intentions.
2. Complete the Gift of Grain Donation Form and mail it to:

You will be sent a gift receipt for your records. Please consult your tax advisor for the appropriate tax deduction for your gift.

3. When you deliver the gifted grain to the local elevator, ask the grain elevator to issue a Grain Transfer Authorization (GTA) Form in the name of Greater Northwest Kansas Community Foundation. The GTA Form is evidence that the ownership of grain was transferred from the farmer to GNWKCF for the **benefit of the Cheyenne County Kansas Community Foundation**. Mail the GTA Form, copy of storage receipt, and Gift of Grain Donation Form to GNWKCF.
4. If the elevator does not have the Foundation's Gift of Grain Policy on file, instruct the elevator that they must contact GNWKCF at 785-734-2406 for selling details. ~Thank you for your Gift of Grain!
